Member's signature is evidence of acceptance of the above agreement and to the adherence of all Club Brennan's rules and regulations. Member is reminded that their guests are the responsibility of the member hosting the party and they are expected to uphold Club Brennan's rules and regulations as well.

**Rules include, but are not limited to:**

- Private parties may be held at the discretion of the Manager; all guests of parties are the responsibility of the member hosting the party; parties are held between specific hours and all guests must leave the party at the end of the specified time **or member will be charged an additional hour**
- Alcoholic beverages are **strictly prohibited**. Public Drunkenness is against the law; police will be called if it is noted by members or staff.
- Grills can be used but must be cleaned after use
- Obey and respect the Lifeguards. They are the Authorities and are here for our safety.
- A shower must be taken before entering the pool to ensure proper hygiene.
- Proper swimming attire is required. Cut-off shorts and t-shirts are not permitted.
- Toys are allowed in the pool at the lifeguard's discretion. Please ask first.
- Children who are not toilet-trained must wear a swim diaper *at all times*. Staff reserves the right to ask/check before young member's use of facility.
- Swimming in the deep-end is allowed after you have passed the "deep water test" administered by the lifeguards. This rule applies to everyone under 12 years old.
- No diving (head first) in any area of pool.
- Lap lanes are for adults (18 years & older); and are for lap swimming only.
- Physical/verbal altercations are prohibited and warrant calling the police.
- Foul language is prohibited
